#### Slide 3: CDAC Statistics Data: Booked Hours:

These next couple of slides provide updates around the utilisation rates of the facility in terms of the Booked Hours and the number of Participants over the last five years. Note this data does not capture utilisation by our Tenant Groups or persons who come in for other purposes. As you can see in 2023/2024, the Centre saw an increase in Booking Hours of 671 that is the equivalent of adding an additional 28 days or a 12% increase and an increase in Participants (persons visiting the Centre) of 5,124 (from 22,749 to 27,873) or almost 23%.

### Sustainable Places Action Fund – 'Kai for All'

As part of Auckland Council's Sustainable Places Climate Action Fund, each of the Kaipātiki Community Houses received \$1,300 funding towards taking action around our Sustainable Places Scorecard in the area of the 5 Pou: Te Tiriti, Zero Waste, Community Resilience, Kai for All, and Carbon Zero. The aim of the workshops was to raise awareness in our community of how food sustainability affects our everyday lives and carbon footprint by showing you how to make small changes in your meal choices. The workshops were hosted here at the Centre, the first was for the general public and the second for one of the ESOL classes.

#### Slide 6: Foster Te Ao Māori:



*"Foster the use of te reo, tikanga (protocols), mâturanga (knowledge) and New Zealand history. Work to strengthen partnerships with tangata whenua as Treaty partners."* 



#### Matariki

Focusing on the theme of the Puriri tree and moth, we used funding acquired through KCFT to provide professionally-printed Puriri moth masks to decorate by the children in the Te Kōhanga Reo o Ngā Tikanga Pono, Birkdale/ Beach haven, Highbury House and Sunnynook ECEs, and erected the 9 Matariki corflute posters in our courtyard again as an educational resource.



Slide 7: Address Inequities and the High Cost of Living:

"Address barriers to inclusion, including reducing inequities including digital inclusion, and find new and innovative ways to help address the high cost of living."

#### **Food Security Network**

One of the areas of need we are seeing increasingly is around Food Security. Takapuna North Community Trust began facilitating meetings held at the Sunnynook Community House starting last year in order to help provide useful networking and information around ways our Community Facilities can assist in supporting those persons in our community suffering from the cost of living crisis around access to food. We continue to run community gardening workshops alongside Kaipatiki Project and the Compost Collective and are in the process of setting up a website that will provide resources around growing in NZ conditions, vertical gardening, planter box gardening, worm farms, water collection and irrigation.

# Rotary Kaipātiki Charity Book Fair

We assist annually with this large local charitable fundraising and recycling event by advertising it on our social media, through use of the KLB Community Billboards and taking book donations. This year the event was staged again at Northcote College during the July school holidays, sold close to 100,000 books and raised around \$48K before costs. MS Auckland were a partner and for their assistance were granted \$17K with the rest of the money to be directed toward charitable causes around the Kaipātiki community.

## Community Emergency Response Plan

We are part of the Kaipatiki Community Emergency Response Group that has been established by KLB and facilitated by Rachel Orr and KCFT with an aim to increase local climate resilience and sustainability. The group's first Planning hui was held on 30 July to discuss the scope, how our community facilities can assist in an emergency, be it climate-related or otherwise, and to increase our overall level of emergency literacy and preparedness.

#### **Sustainability Action Plan**

Auckland Council are integrating sustainability KPIs as part of their Community Service Agreements including ours. We have already undertaken an audit, completed a survey and a have a draft plan outlining things we will seek to do at the Centre to reduce our carbon footprint and maximise sustainable practices. The plan has been completed and circulated to Governance for review and feedback. Two items – replacement LED lighting for existing fluorescents and replacement water heaters are priorities as in the case of the former, they are being phased out due to them containing mercury and in the latter, because the units are 30 years old, too large, inaccessible and should be migrated to solar. Quotes are being sought along with funding options.
